Hope all is well with you. As requested, please see attached invoice for reinstatement of the corporation. Due to the State of Nevada's filing fees being legislatively increased effective June 1, 2015 the amounts reflected in the attached invoice are greater than the invoice we prepared for you in May 2015.

Immediately upon recording of the reinstatement we will prepare and file amended/restated articles of incorporation adding indemnification language and amending the par value of the shares as to reduce the annual filing fees from \$4750.00 plus RA fee(s) to \$650.00 plus RA fee(s). The next annual fees of \$650 plus RA fee of \$100.00 will be invoiced in June and due in May 2016. *Note: if amended Articles are not filed previous to 1 May 2016, the annual filing fee will be the higher amount.*

As per NRS78.180; The Secretary of State shall reinstate a corporation which has forfeited or which forfeits its right to transact business pursuant to the provisions of this chapter and shall restore to the corporation its right to carry on business in this State, and to exercise its corporate privileges and immunities. Reinstatement pursuant to this section relates back to the date on which the corporation forfeited its right to transact business under the provisions of this chapter and reinstates the corporation's right to transact business as if such right had at all times remained in full force and effect.
